## Medical products

### Product description

#### Composition (materials used):

Moulded fibre products made of recycled paper and fresh fibre or only recycled paper with the addition of process-related and functional additives.

#### Intended use:

As medical devices for use in the medical field, e. g. in hospitals, old people's homes, nursing homes etc. and doctor's surgeries for the collection of body fluids or to drop instruments according to their use and before their cleaning.

#### Restriction of use:

Hot and/or frozen substances, alcoholic solutions, microwave, sterilization processes.  
Do not reuse!

#### Storage and transport conditions:

We recommend a storing temperature of 15 – 30° C and a relative humidity of 50 – 60% for these products. If stored in a non-air-conditioned environment, please protect the products from humidity as well as direct sunlight and too humid and too dry air (blow pipe).

We recommend a shelf life of five years under the specified conditions.

#### Other:

Goods are sensitive to mechanical impact and must not be subjected to impacts or high pressure be exposed. Goods must be protected from moisture and humidity. Use outside the intended purpose is the responsibility of the user.
